**Title of Session:** Modernity and the Futures of Capitalism in Eurasia: Challenges for Inquiry and Teaching.

**I) Title of Selected Paper:** "The Future of Capitalisms in Eurasia: Institutional and Comparative Perspectives"

**Abstract:** The paper argues that a proper understanding of capitalism is lacking in current sociological production. In order to gain such an understanding, sociologists need not only the theoretical and methodological systems of coordinates but the thoroughly done empirical researches. That would be the only way on the road to recognize what a society we live in.

The Enlightenment upheld three fundamental principles (or ABC of Capitalism):

- a) the rational mind,
- b) the rights of the individual,
- c) the economic and political freedom.

The paper will go for an exploration of the realities in contemporary societies of Eurasia through the lens of institutional settings and comparative perspectives.

The first issue to be examined is the Eurasian societies' attitudes toward Enlightenment principles of respect for rationalization, individual rights and political-economic freedom.

The second is the socio-economic results of the transformation processes that can be measured and reflected upon through empirical data.

What follows will be an attempt to look at the possible future scenarios for modernity and institutions of capitalism building in Eurasia.

II) Title of Selected Paper: "The Global Factory: Origins, Organizational Forms,

Morality and Future"

Abstract: The modern capitalism is increasingly governed by global factories - transnational supply chains. What are the fundamental factors of this phenomenon? What organizational forms does it take (outsourcing, OEM, off-shoring, near-shoring etc.)? What moral or economic problems does it rise (inequality, exploitation, dependency)? And what are possible future destinations of this large scale movement? These issues can be effectively analyzed with the help of economic theory, contract theory and modern ethics.

III) Title of Selected Paper: "Creating a Common European Higher Education Area:

Modernization of Education and Society?"

**Abstract:** Globalisation, the internationalisation of academia as a whole, and the Bologna-process has recently placed European higher education in a state of change. By critically reading the discourse, three intrinsic internationalisation ideologies (idealism, instrumentalism and educationalism) in higher education have been identified. By drawing from the objectives and ideals of these ideologies, and using concrete examples, this article argues for a shift in focus and also identifies desirable outcomes of internationalised education – where special attention is paid to different aspects of intercultural competence. It is concluded that a somewhat new approach to internationalised education will further enrich higher education, contribute to students' self-development and enable them to acquire adequate intercultural competencies for the future.
